Reproduction and Licensing Services

All fees and other information effective as of October 10, 2018. Services and fees are subject to change without notice.

Conditions and Procedures: Licensing and Duplication Fees for Images/Digital Media

- All rates are calculated "per image" unless otherwise noted.
- The Museum does not provide exclusive rights for the use of its material.
- All licensing requests must be accompanied by a *Rights and Reproduction Application* form.
- All licensing periods are for one-time use only, and for an unspecified time period unless otherwise noted for the usage below. Subsequent use of an image requires the written permission and the payment of additional fees.
- Prepayment is required for all photocopy services and research services.
- Postcards, posters, calendars or other single-use, mass-reproduced products are subject to special contractual agreements with the Museum.
- The Museum does not allow image modification or out of context representation.
- Reproduction does not imply permission to reproduce under United States copyright law, nor does it indicate that the Northwest Museum of Arts & Culture owns copyright or non-exclusive license rights.
- All fee rates are adjusted at a 10% discount for museum members, non-profit 501(c)(3) organizations, or book authors with self-published works under 2,999 copies.
- Fee discounts do not apply to photocopies, shipping and handling charges, or sales taxes.
- Rush orders requested for completion within a 24-48 hour deadline will incur a \$25 service fee, and are also subject to staff review for fulfillment. If an order cannot be completed within a 24-48 hour time frame as requested, the patron will be advised in advance.
