# CONDITIONS GOVERNING REPRODUCTION OF MATERIALS FROM THE COLLECTIONS OF THE NORTHWEST MUSEUM OF ARTS & CULTURE/EASTERN WASHINGTON STATE HISTORICAL SOCIETY

(hereafter referred to as the Society)

## PERMISSION IS GRANTED FOR ONE-TIME USE

Permission is granted for one usage in one publication, production, web-site, broadcast or product as specified on the face of this agreement. Subsequent publications, revised new editions, re-issues, web-sites, broadcasts products, and additional language editions require separate agreements. Photographic material may not be reused without the written permission of the Society.

## CREDIT AND DOCUMENTATION

Credit and documentation must appear on the same page as the reproduction, or on the opposite page, or on the reverse unless otherwise agreed to in writing. In the case of films, videos, and any electronic media, visual credits must appear at the beginning or the end. Any exceptions must be approved by the Society in writing.

*CREDIT LINE:* Must include the following elements:

**a) Northwest Museum of Arts & Culture/Eastern Washington State Historical Society, Spokane, Washington, b) the item's identification number, c) the individual artist, photographer, or creator, if known.**

## IMAGE ALTERATION

Reproductions in any media may not be altered, cropped, bled, or overprinted, and nothing may be superimposed on a reproduction image. If image details are utilized, the "detail" must appear in the caption or otherwise referenced.

## COPYRIGHT

For artworks by living artists and other material subject to the 1976 Copyright Act, (Title 17, United States Code) written permission to reproduce must be secured by the licensee from the artist, their agent, or copyright owner. The licensing of collection materials for reproduction by the Society does not imply permission to reproduce under United States copyright law, nor does it represent that the Society owns copyright or non-exclusive license rights.

## INDEMNITY

The Society assumes no responsibility for copyright infringement by the licensee, or for royalties or fees claimed by a copyright owner or other third party. Licensee will indemnify and hold harmless the Society from and against any and all claims, damages, liabilities, costs and expenses including attorney's fees arising from Licensee's use of Society materials. The Society reserves the right to refuse permission for any use of its collections that may jeopardize the integrity or purpose of the Society and its collections.

## REPLACEMENTS

A charge equal to the replacement cost will be made for any color transparency, or other rented or loaned reproduction material, not returned within three months or returned in damaged condition.
